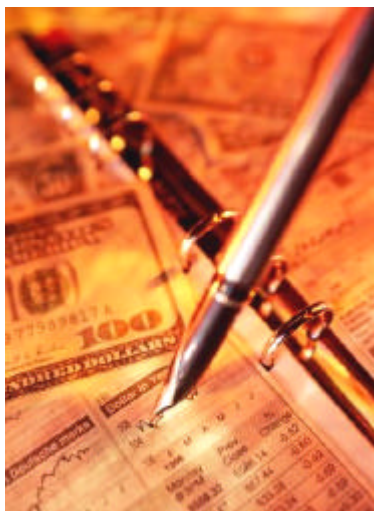
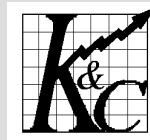

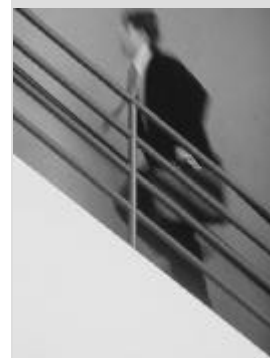
## ABOUT THE COMPANY

Owing to the above factor, K&C has a very high level of employee-loyalty and motivation and very low level of employee-turnover.



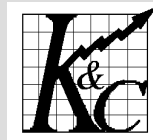

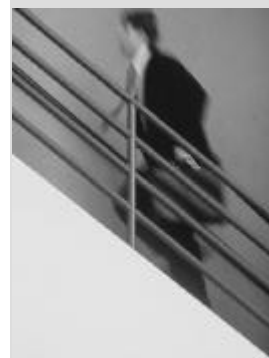

K&C has a complete collection of Books/Magazines/Publications/CDs related to its work.



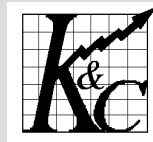
